PROPSAL by Mike Guzman

- Bring NGA into Nor-Cal with a Representative on the Executive Board.
 - SECOND: Bill

 - Dona Jones gives permission, as she is the State Rep for NGA. Dona will be the NGA Rep on the Nor-Cal Board

Dona: Need to understand the umbrella

- NAWGJ assigns all Judges regardless of the organization (NGA, Nor-Cal etc.)
- She would agree to be the assigner for NGA
- NGA is not a replacement for USA Gymnastics
 - Separate alternative organization
 - Rules parallel NCAA's
- Contact Dona for info about NGA
- Donna: USA Gymnastics Rep on Nor-Cal Board has no vote, the same would apply to NGA Rep

NGA

- Clubs would register with Nor-Cal, but declare USAG or NGA (or both)
- NGA athletes that want to go to Woodward would need a USAG number as it is a USAG sanctioned event

- Levels 8-10 are somewhat the same
- Nor-Cal Membership will vote on NGA at the General Meeting

General Membership ZOOM meeting will be on Saturday, June 19, 2021, at 9:30am. Zoom info will be sent out the Monday before.

There is no bid for Level 3 State Championship at this time.

Level 4/5 State will be hosted be CCGI at the Visalia Convention Center, November 20-21, 2021.
